## Enrollment Agreement

**I am enrolling my child(ren) with the full understanding of Meadowbrook's refund/withdrawal policy as stated below:**

- The application deposit is nonrefundable unless there is no space for my child.
- A reduction in the enrollment period will result in the automatic forfeiture of the deposit for the dropped time period.
- The balance of the tuition is due by April 1<sup>st</sup> to maintain my child's reservation.
- No adjustments – in weeks or money - will be made due to any school/camp conflict, routine illness, or change in family plans.
- For enrollment changes and withdrawals after May 1, a tuition refund (less the deposit) will only be given if the camp is able to fill my child's position in his/her group. Refunds will be processed in September.

**I understand that Meadowbrook's medical form – showing all required immunizations – is due by May 1.**

**I understand that Meadowbrook Day Camp is a peanut aware camp (not a peanut free camp) and that campers will be asked not to bring in food containing peanuts for lunch or snack. (See policy statement on the back of this page.)**

**I have reviewed and understand the behavior expectations as stated on the other side of this form.**

## **Meadowbrook Day Camp's Peanut Policy**

As a peanut aware day camp, Meadowbrook strives to avoid all peanut products. Therefore, we ask for parents' cooperation in not sending any food containing peanuts to camp. This includes (but is not limited to) peanut butter sandwiches or crackers, peanut butter cookies, trail mixes, candy containing peanut butter and peanut snacks. Meadowbrook cannot guarantee that it is 100% peanut free, but it is willing to support families with this issue as they learn to manage their child's medical needs.

## **Behavior Management and Expectations**

The focus at Meadowbrook is based on the staff providing positive role models for campers and assisting them to develop self-discipline. It is the expectation of Meadowbrook Day Camp that all enrolled campers will be able to function within a group environment and to make positive behavioral choices that promote an emotional and physically safe environment.

The Director reserves the right to suspend or expel a camper if the Director decides that Meadowbrook is not the appropriate program for the camper.

Often, potential issues can be thwarted by open communication between parents and camp staff. To that end, Meadowbrook encourages parents to discuss any special concerns or needs that may affect their child's participation at camp with the Director at the time of registration.

Meadowbrook's behavior management policy is available to parents upon request.

## **Bus Transportation Notes**

Meadowbrook Day Camp provides bus transportation at no additional charge from Weston, Wayland, Newton, Wellesley, Lexington and Needham at designated pick-up/drop-off locations. The stops and routes will be similar to last summer's (see enclosed schedule). However, the camp reserves the right to change routes, stops and pick-up/drop-off times based on camper sign-up and effectiveness of routes. A sign-up form will be provided in the spring.

The camp will provide a camp counselor to serve as a bus monitor on each of the routes. The monitor will be responsible for taking attendance and maintaining order on the bus. He/she will have a cell phone in case of an emergency. Water will be provided for campers on the return trip home.

**Campers who will have an Epi-pen at camp must speak with the camp director prior to bus registration.**

We anticipate using Local Motion as our transportation company again this summer and they have confirmed that all their buses have seat belts.

## **Carpools**

While Meadowbrook will try to assist you in forming carpools, it is the parents' responsibility to form their own carpool and to provide that information to the camp.
